PROFILE OF THE TRAINERS	The São Paolo training programme was delivered primarily in Portuguese by experienced local trainers who had completed CIDOC Teacher Training. Advanced modules were delivered in English (with simultaneous translation) by CIDOC trainers: board members and chairs of WGs.

4) RESEARCH ACTIVITIES

Work has started on a collaborative, multilingual project to catalogue the terminology of museology, inspired by the *Dictionarium Museologicum*, published by CIDOC in 1986. This is an online resource to which experts in the field may contribute – ensuring that the catalogue of terms and concepts used by the museum profession can be updated to reflect current usage.

The CIDOC check list, a self-test to rapidly evaluate the quality of an institution's documentation, was made available on the CIDOC website. The document has been translated into Portuguese. We plan to develop an online version and to provide translations in French and Spanish.

CIDOC working group have continued development of CIDOC's recommendations, notably LIDO and the CIDOC Conceptual Reference Model.

CIDOC has formalized a process for the acceptance of working group publications as CIDOC recommendations. This is to avoid confusion about the status of documents produced as part of an ongoing project.

ISO published an updated version of the CIDOC CRM: ISO 21127:2014. This is available in English and French.

6) ACTIVITIES CONCERNING MUSEUM DOCUMENTATION, GENDER EQUALITY, THE PROTECTION OF HERITAGE DURING ARMED CONFLICTS AND THE SUSTAINABLE DEVELOPMENT OF MUSEUMS*

As in 2013, basic training modules were delivered directly in the local language or with simultaneous translation. Simultaneous translation was also provided during plenary sessions at the CIDOC conference in Dresden

CIDOC continues to maintain its website in the 3 primary ICOM languages. Messages sent to the CIDOC membership are translated whenever possible into the three main ICOM languages.

The CIDOC newsletter is published in both English and French.

Thanks to a generous grant from the Getty Foundation, twenty delegates from developing

countries received bursaries to attend the CIDOC conference. In addition, CIDOC provided funding for five additional delegates from its own funds. CIDOC covered registration fees for another two delegates who benefitted from the ICOM bursary scheme.

Four introductory modules from the CIDOC training programme are now available online in a format suitable for use over low-bandwidth connections.

The translation of key CIDOC recommendations into different languages is aims to promote the quality of museum documentation and to support the profession at an international level.

7) SYNTHESIS OF THE ACTIVITIES AND OBTAINED RESULTS

This year's annual CIDOC conference took place Dresden, Germany. Around three hundred people attended the conference, a considerable increase on our 2012 conference in Helsinki. The conference was notable for the friendly atmosphere of exchange and cooperation. Our two major audiences – museum practitioners, on the one hand, confronted every day with the practical reality of their institution's documentation, and specialists in information science, on the other – were able to get together and find common ground, where new technologies can be of practical benefit. Many delegates also commented on the uncompetitive and 'nurturing 'character of the conference, where old hands welcome new delegates and help them to get their bearings. This is an important aspect of CIDOC's organisational culture that contributes to the committee's unique character.

Building on the success of the 2011, 2012 and 2013 sessions, CIDOC organized a fourth U.S.A. Summer School in 2014, focusing on the principles and practice of museum documentation. The programme is organised in collaboration with the Museum of Texas Tech University (MoTTU) and regularly welcomes UNESCO funded participants. The number of participants increased this year to twenty one. Our training programme in São Paolo was also a success. Ninety students attended the classes, exceeded our expectations. A similar number had to be put on a waiting list. We are planning a similar series of classes in 2015. A week of training will also be taking place in Jyvaskyla, Finland. Four modules from the CIDOC training programme have been made available online, providing access for members who are unable to attend the workshops in person.

The CRM SIG, chaired by Dr Martin Doerr, established successful extensions to the CRM in cooperation with IFLA and a newly updated version of ISO 21127, the ISO version of the CIDOC CRM, was released. A new working group, dealing with the documentation of intangible cultural heritage held its inaugural meeting during the CIDOC conference, chaired by Dr Manvi Seth. The Data harvesting and interchange working group was renamed the LIDO working group, in order to highlight its main focus.

CIDOC began discussions with ICOM Namibia with respect to the *Africa Accessioned* project. The first stage The first stage, identifying institutions interested in participating is now complete. The second stage, planned for 2015, requires development of a system for sharing information. CIDOC can provide useful expertise in this area.

Two key CIDOC reference documents, the International Guidelines for Museum Object Information: The CIDOC Information Categories, and the Statement of Principles of museum Documentation, ratified by the General Assembly in 2013, were translated into Portuguese. (Both documents were translated into French in 2013.) These texts are now regularly cited in scientific writing and are used in museology courses throughout the world. We are planning a Spanish translation for 2015.

A considerable number of papers and other documents from past CIDOC conferences have been digitized and are now available online from the CIDOC digital library. These documents form a valuable resource for research and education. Papers for the 1995 and 1999 conferences were added in 2014.

CIDOC obtained a generous grant from the Getty Foundation, enabling participants to attend the CIDOC conference. CIDOC used its own bursary fund to enable delegates to attend the Dresden conference and students to attend CIDOC training programme.

CIDOC membership increased again in 2014. We hope to build on this success and continue to attract new members.

4) PLANNED RESEARCH ACTIVITIES

The new working group on the documentation of intangible heritage will be looking at the development of recommendations for documentation.

Part one of the CIDOC self-evaluation check list allows for easy evaluation of museum documentation quality. Part two, under development, focuses on museum processes. We intend to refine and add to these documents and to develop online resources.

Other CIDOC working groups continue the development research into their respective areas of interest.

5) ACTIVITIES CONCERNING MUSEUM DOCUMENTATION, GENDER EQUALITY, THE PROTECTION OF HERITAGE DURING ARMED CONFLICTS AND THE SUSTAINABLE DEVELOPMENT OF MUSEUMS*

All CIDOC's activities concern museum documentation.

CIDOC operates a non-discrimination policy. This applies to race, creed, nationality, gender, age and physical disability. We do everything we can to ensure that CIDOC's activities are accessible to all.

CIDOC will continue managing a bursary scheme to assist participants from developing countries in attending the 2014 conference. We will also apply for a grant from the Getty Foundation.

CIDOC board meetings are held online to facilitate the participation of board members outside Europe. In addition we provide financial assistance to allow board members to attend meetings in person when needed.

We will be continuing our effort to digitize and make available papers from CIDOC conferences and back numbers of the CIDOC newsletter.

6) OTHER PLANNED ACTIVITIES

We will continue our efforts to find ways of improving the quality of our membership lists, as well as contacting and enrolling new CIDOC members.

We are conducting a systematic review of existing CIDOC recommendations and publications. Documents that were originally published in paper form are being digitized and made available as electronic documents. Key documents that are still of relevance are being translated into the three main ICOM languages.

Papers from the 2014 and 2015 conference will be made available through the CIDOC digital library.

CIDOC will provide expertise and support for the Africa Accessioned project, organized by ICOM Namibia.
